PRESIDENT'S REPORT

WVAGP – Annual Membership Meeting President's Report

June 23, 2020

The 2019-2020 year has been a year of change. Our midyear meeting successfully changed venues this year to Adventures on the Gorge, offering new grounds to gather on. The Corona Virus Pandemic has instigated significant change for everyone this year. Some of our own members have been furloughed, some have been working remotely and most certainly budgets are going to change. Covid-19 forced change upon us and using the data and direction we had at the time, cancelled our plans for the West Virginia Semi-Annual GIS Conference.

Our goals this past year was to also provide for training and support to our users, facilitate dialog and inter-agency cooperation, as well as connect users who share their experiences with one another.

The Annual meeting was a big loss to our organization this year. Part luck, part planning, WVAGP did not incur significant financial loss, but we lose out on the meetings benefits. Our Annual Conference and membership meeting is intended to serve GIS Users in this state. It creates a forum to exchange experiences, both failures and successes. It helps us generates new ideas and borrow best-practices to apply to our own. The conference provides an environment that facilitates discussions between managers and users, policy makers and technicians. This is what we lose, but we will adapt. Change will come again as we reclaim our lives from this pandemic. Applying the lessons learned, keeping the good (remote work) and discarding the rest. WVAGP board has already began discussions for planning both a mid-year meeting and are in the beginning stages of planning next years conference. Join us in these discussions by volunteering to sit on the conference committee.

This year's agent of change has pushed us to focus on getting additional topics of training but offering also offering courses online. We expect additional courses and resources to be made available over the next year, creating a work-around to meeting in person and adding flexibility of schedules and travel restrictions.

I want to take the opportunity to thank the board members, who have put in the work to facilitate conferences, meetings, trainings and exchange of ideas for GIS users in WV. They truly work hard and I'm grateful for it. I also want to thank you as members, who put forth the effort and commitment to assist each other and advance GIS in WV. This coming year will see additional challenges and change, and we are preparing to adapt and continue to serve the GIS users in the great state of West Virginia.



The Conference Planning Committee worked very hard this year to plan an outstanding conference. JulNet was hired to assist us in conference planning. The 2020 WV GIS Conference was supposed to be held June 1st-4th at the WVU Erikson Alumni Center in Morgantown, WV. Unfortunately, COVID-19 derailed our plans and hard work. We were forced to cancel the in-person conference. Starting in April 2020 we began planning a virtual Annual Meeting via Zoom. Our Annual Meeting will be held on June 23rd, 2020.

We also began to explore ideas and locations for our 2021 Annual Meeting, but this was put on hold due to COVID-19 complications.

Election Committee

The committee has worked hard this year to continue to increase voter turnout and prepare for the 2020 WVAGP Board of Directors election. In regards to increasing voter turnout, the committee met their goals of a WVAGP Membership vote that gave the election committee the ability to try methods to increase voting, including the implementation of electronic voting. This vote was fortuitous given the current situation that has impacted holding face-to-face elections.

At the 2020 WVAGP elections, we have 7 qualified candidates for the six seats that are available. As was done in past years, the committee added candidate pictures to the nominee profiles to put a face to each nominee profile. The election committee has been working with the WVAGP conference committee and Julnet to integrate the election process into the upcoming virtual WVAGP conference. Election of the new Board of Directors members will be at the annual membership meeting in June 2020. Members of the committee include Barbara L. MacLennan (Chair), Jennings Starcher, Jessica Brewer, Nate Davis, Ben Everette, Steven Harouff, and Maneesh Sharma. The Election Committee is actively seeking new members.

Technical Issues Committee

I, Steve Harouff was re-elected in 2019 to the Board as an alternate, which allowed me to continue as Chair of the Technical Issues Committee. Over the past year, as committee chair, I helped organize and participated on the UAS Panel for the 2019 WVAGP Annual Meeting. I also coordinated the use of one of the Division of Forestry's drone pilots to take a group photo of those in attendance at the annual meeting.

I worked with board member Frank Lafone and WVAGP Treasurer, Jennings Starcher to set up a new domain account for WWW.WVAGP.ORG, which was previously under the WVU GIS Tech Center's account. I also took over the free conference call number account used by the Board.

I worked with Communications Committee Chair, John Bocan reviewing the WVAGP website to determine needed changes and updates and provided a list of needed changes.

I reviewed the WVAGP strategic plan to get familiar with the document for planned future updates.

The Technical issues committee was asked to review any existing State legislation for the official state and county geospatial boundaries. Working with state GIS Coordinator Tony Simental, we had conversations with Director Mitch Blake from the WV Geologic Economic Survey, the official steward of the State Boundary. No official legislation was found, so this issue will be taken up by the State GIS Steering Committee as part of the Next Gen E911 project by coordinating with surrounding states on an official working geospatial boundary that will align with surrounding states. Necessary legislation will be coordinated through the WVAGP and other stakeholders.

The committee was also asked to review the new Datum 2022 being developed by the National Geodetic Survey (NGS). NGS is replacing NAD 83 and NAVD 88 with a new geometric reference frame relying on global navigation and positioning systems, along with gravity measured geoid models, which will all are easier to maintain. The project however is on hold as collection of gravity data measurements needed for the project are currently on hold. State GIS Coordinator, Tony Simental has indicated current legislation based on NGS templates is in place at this time for the transition to this new Datum. Future coordination is planned with federal partners to provide status updates for future meetings to the WVAGP.

As Technical Issues Committee Chair over the past year, I participated in all but 1 monthly Board meeting, various special meetings, providing support as needed to the other committees, helping with annual meeting planning and voting on WVAGP Board decisions. This has been a very rewarding experience and I look forward to continuing as a member of the WVAGP Board.

However, most registrants for Foundations, ArcGIS Pro, and ArcGIS Online opted for refunds and cancelled their registrations.

Upcoming Sessions Report

COVID-19 hit us hard in the ability to provide any in-person training sessions, so we have been forced to attempt virtual courses, with the help of Aaron Maxwell and Kevin Kuhn. The development of these courses has been Aaron's responsibility due to his expertise and the courses (ArcGIS Pro and ArcGIS Online) being his own. The Training Committee is taking more of a stakeholder input role instead of active development or scheduling of courses until these sessions are ready to go. The plan is to hold the courses in the late fall of 2020, but that is very much preliminary at the time of this report.

Courses in Development Report

The Training Committee worked with ESRI to do an ArcGIS Field Data Collection course as a standalone attempt at a pilot venture of a WVAGP-sponsored ESRI training event. We reached the stage to schedule the training, but it was made unnecessary by a planned Field Data Collection workshop at the WV GIS Conference, which was subsequently cancelled due to COVID-19. The experience, even though it did not come to fruition, did showcase the possibility of utilizing other vendors to bring specialized training courses WVAGP does not currently offer to WV.

The Training Committee has established a rough basis for a "ArcGIS Mobile Apps" course that will tie-in to a "third day" for the offered ArcGIS Online course, due to the need for users to understand ArcGIS Online before using the mobile apps. The course will focus mainly on Collector and Survey123, but also dip into Workforce and Explorer. Due to COVID-19, this course development should be a priority of the committee for the next year, so it is ready for the next in-person course for ArcGIS Online.

Final Thoughts

Once again, the Training Committee was very active in participation in monthly meetings and input in the development of courses. While we have had to adjust during the times of COVID-19, I have remained proud to be chair of this committee due to the hard work of its members.
