
Thank you for the opportunity to serve on the board and as vice-president. It is an honor to work in this field and alongside all of you.







Audit Committee

As Chairman of the West Virginia Association of Geospatial Professionals Audit Committee, I am pleased to present the report of the Committee for the year ended December 31, 2018. Which has been prepared by the Committee and approved by the Board. While a comprehensive description of the financial status of our organization is included in the Treasurer's Report I would like to highlight a number of aspects of our work.

One of the Audit Committee's key responsibilities is to review our organization's finances and accounting systems. In addition the Audit Committee is also responsible for the oversight of the Treasurer's performance.

The Audit Committee recognizes the importance of its responsibility and transparency, both in fact and appearance. Each year, the Committee evaluates the financial records related to income and expenses, including bank account balances.

The Audit Committee reviewed all the pertinent records presented by the Treasurer prior to reporting the results to the Board. This included a review of the accounting practices, major expenses and main income streams. The Audit Committee discussed these matters at length with the Treasurer as part of the review. Election Committee

The committee has worked hard this year to continue to increase voter turnout and prepare for the 2019 WVAGP Board of Directors election. In regards to increasing voter turnout, the committee met their goals of 1. creating a white paper reviewing what similar geospatial organizations do for voting and elections in other states, 2. based on this information and after talking to WVAGP founding and current board members about the election rules, rewrote the election by-laws to be able to try new approaches to increase voter turnout. These changes will be presented for a vote at the 2019 WVAGP conference for the consideration of members to determine next steps.

At the 2019 WVAGP elections, we have 7 qualified candidates for the five seats that are available. There are two candidates representing the state constituency, three representing the education and research constituency, one candidate representing the regional/local government constituency and one candidates representing the private sector constituency, and no candidates representing the federal constituency. As was done in past years, the committee added candidate pictures to the nominee profiles to put a face to each nominee profile. Ballots and nominee profiles were sent to the membership on April 12, 2019. Also, the committee worked with the Communications Committee to spotlight each candidate on the WVAGP Facebook page leading up to the election. Election of the new Board of Directors members will be at the annual membership meeting May 13-14, 2019. Members of the committee include Barbara L. MacLennan (Chair), Jennings Starcher, Jessica Brewer, Nate Davis, Ben Everette and Maneesh Sharma. The Election Committee is actively seeking new members.

Scheduled Sessions Report

Once again, GIS Foundations continues to be our most popular and attended course. We held two instances in 2018, with one in Morgantown and the other in Beckley. Coincidentally, the City of Oak Hill (my employer) took advantage of the Beckley training, which they found very helpful for their efforts in our daily operations. We had one or more courses not meet the attendance needed to be financially viable, with JavaScript being cancelled. Since JavaScript has struggled to meet the established threshold, it is not being offered for summer 2019.

Kevin Kuhn had brought up a situation where a registered attendee had to cancel due to an emergency and had to be refunded, which sparked a conversation that WVAGP's Training Committee and/or Board does not have a policy regarding course registrations and cancellation. I believe it should be considered by the Board to establish either a policy of either providing refunds/rain checks to those who must cancel for good reason, because we cannot foresee hardships come up, but we must also acknowledge that the cancelled registration takes a seat away from someone who would have paid to take that course.

We also had a lengthy discussion about remote courses held outside of Morgantown. Due to travel and lodging for the instructor of the Beckley GIS Foundations course, WVAGP had extra costs incurred that should be a case for increasing the needed attendance threshold for scheduled remote courses by one or two registrants, so WVAGP can assuredly "break even" for the course.

Upcoming Sessions Report

The Training Committee made sure that we had a schedule training for ArcGIS Pro due to the current shift taking place at ESRI to get users to switch to the newer platform. We went through several iterations through the last two years, from having a "GIS Foundations" type of ArcGIS Pro course, to just having a "switching to ArcGIS Pro" course, to officially combining both ArcGIS Pro and ArcGIS Online to the same week since both platforms are so interconnected. I hope to see a report after the courses are held to see if there are any needed tweaks, however, the committee is very excited to get two long-gestating courses onto the schedule.

As stated before, JavaScript will not be offered this summer, but it will be kept in the offerings and rescheduled if interest returns. Python and Geostatistical Analysis both teetered on the attendance threshold this past instance, but went on as scheduled due to any budget loss not being a burden.

From my experience with the Training Committee, we tend to keep a very good eye on what trainings are desired by the membership and even organizations that don't have a strong presence in WVAGP. I feel this summer's offerings will be well-attended, especially with knowledge of many organizations buying into a regional purchasing agreement from ESRI.

Courses in Development Report

The Training Committee has established a rough basis for a "ArcGIS Mobile Apps" course that will tie-in to a "third day" for the offered ArcGIS Online course, due to the need for users to understand ArcGIS Online before using the mobile apps. The course will focus mainly on Collector and Survey123, but also dip into Workforce and Explorer. I am hopeful the next offering of ArcGIS Online in 2020 should include the Mobile Apps course.

We have begun working on a potential Udemy course for Story Maps, which offers the opportunity for us to do either paid web courses or MOOCs (Massive Open Online Courses). There hasn't been much progress made as of now, but that is a goal of mine if I continue as the Committee Chair this next year.

Finally, there has been discussion about a joint Cadastral Management workshop that would be in conjunction with the WV Society of Professional Surveyors, but no developments have come of that at the time of this report.

Final Thoughts

The Training Committee has done a superb job this past year in addressing issues that have arisen, but also getting new course offerings scheduled and utilizing a new remote location for GIS Foundations in Beckley at WVU Tech. We are also very energetic about developing web courses or MOOCs to help accommodate professionals at all corners of West Virginia. The Committee has done a wonderful job this year, and I have felt it a privilege to serve as its Chair. None of this would be possible without the WV GIS Technical Center and I want to commend them on all that they do to help train our geospatial professionals.
